

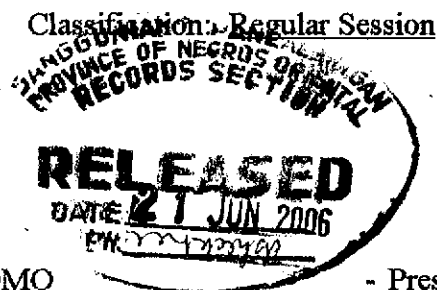

“Whereas, said resolution conforms to the provisions of the Local Government Code of 1991;



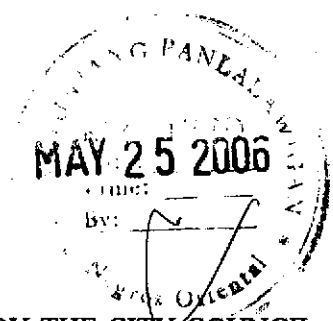

RESOLUTION NO. 235

“Third and Final Reading of An Ordinance Prescribing Safety Measures in Refueling at Any Filling Station within the City Of Bayawan and Providing Penalties in Violation Thereof.

“On motion of Honorable Councilor Raymond and duly seconded by Honorable Councilor Renacia, the Council

“RESOLVED, To enact, as it hereby enacts the foregoing ordinance, to wit:

ORDINANCE NO. 25

AN ORDINANCE PRESCRIBING SAFETY MEASURES IN REFUELING AT ANY FILLING STATION WITHIN THE CITY OF BAYAWAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

Be it ordained that:

SECTION 1. Title. This ordinance shall be known as an ordinance prescribing safety measures in refueling at any Filling Station within the City of Bayawan.

SECTION 2. Definition of Terms. As used in this ordinance, the term shall mean

- a. **Filling Station** - A facility that sells fuel and lubricants for motor vehicles and where motor vehicles refuel.
- b. **Pump Attendant** - A person who attends a machine or device in refueling motor vehicles or a person who dispenses petroleum products in a filling station .
- c. **Refueling** - Adding fuel to a fuel tank or any container.

SECTION 3. Prohibited Acts. The following acts are prohibited while refueling at the vicinity of any filling station within the City of Bayawan.

1. Smoking while refueling.
2. Refueling while the engine is still running.
3. Use of Cellphone while refueling.

SECTION 4. PENALTY.

For person found in violation of this ordinance:

First Offense	Warning
Second Offense	PHP200.00
Third Offense	PHP500.00

For Gasoline stations found in violation of this ordinance:

First Offense	Warning
Second Offense	PHP500.00
Third Offense	PHP1,000.00
Fourth Offense	Cancellation of Business Permit

SECTION 5. Filling station owners and operators are hereby directed to post the policies to inform their clientele regarding the safety measures for filling stations and further enjoin them to direct their attendants to remind customers to follow the said notices.

SECTION 6. This ordinance shall take effect after compliance with the provisions of R. A. 7160, the LGC of 1991.


